

- 2. Both the assessment reports alongwith the data available on AEBAS and HMIS including CCTV footage was considered in Under Graduate Medical Education Board (UGMEB) and certain deficiencies were noted. The same were communicated to the college authorities vide UGMEB's letter dated 28.04.2023 for compliance.
- 3. - 4. However, they shall apply afresh for Continuation of Recognition in 2024.
- 5.
