As per the norms of NMC/DME, Bengaluru/Competent authority, student's applying for migration transfer for the academic year 2022-23 are required to submit the following:

1. Requisition letter from the candidate with supporting requisite documents as per criteria.
2. No Objection Certificate & NMC/MCI Recognised Certificate from the parent medical college.
3. RGUHS Prescribed migration transfer filled in application form with seal & signature of the Dean/Director/Principal of parent college.
4. Self Attested Copy of 1<sup>st</sup> MBBS Feb/May 2022 Exam passed result sheet/Copy of Medical Certificate as mentioned in the GOK Notification Dated 4-7-2022

**NOTIFICATION**

As per MCI guidelines pertaining to Graduate Medical Education Regulations vide clause 6(1) and (2), migration of students from one college to another is permissible only, if both the colleges are recognized by Government of India under section 11(2) the IMC Act 1956.

Further, as per Clause 6(1) (4), the office of Director of Medical Education, will take a final decision in the matter as to whether or not, to allow migration in accordance with the provisions of MCI/NMC regulations and communicate the same to the applicants within a period of one month from the date of receipt of their requests for migration.

**The procedure laid down for effecting Migration Transfer for the year 2022-23 is as the follows.**

1. Recognized Medical Colleges should publish the number of seats available for Migration Transfer, in their respective websites, under intimation to DME's office. The number of seats available for Migration Transfer, is subject to the condition that, it shall not exceed 5% of the sanctioned annual intake capacity of the college, which shall be arrived at, after the announcement of supplementary exam of 1<sup>st</sup> year MBBS course results from Rajiv Gandhi University of Health Sciences.
2. Recognized Medical colleges wherein, the students have opted out of the Institution and all the recognized Medical Colleges wherein the students have opted in to come into the Institutions, shall invite applications for Migration Transfer from interested candidates. This procedure shall be completed before 11<sup>th</sup> July 2022 **(11-07-2022)**.
3. It shall be brought to the notice of the students requesting for migration by the Principals of the Medical Colleges, that migration transfer is subject to the candidates fulfilling any of the following conditions.
  - a. Death of one of the parents in the preceding year (Death Certificate should be enclosed).


- b. One of the parents is terminally ill/incapacitated/bed ridden/irreversible organ damage/having orthopedic handicap of 65% and above or permanent visual impairment of 50% and above. (Medical Certificate Should be enclosed)
  - c. If the candidate has physical disability which necessitates the care by parents and in case the candidate is seeking transfer to his/her home town, such candidates after Migration Transfer will not be given hostel facilities and they(physical disability) would be treated as days caller.
  - d. If the candidate is suffering from ailment for which treatment is not available in the place where he/she is studying.
4. No Migration will be permitted on any ground from one medical College to another located within the same city.
  5. The Medical Colleges from where the student is opting out and the receiving Medical College where the student is opting to come in, shall prepare a merit list of all applicants who have applied for Migration Transfer.
  6. The following table indicates the eligibility of candidates for Migration transfer from one Institute to the other:

4. The colleges shall issue NOC to the candidates as per provision mentioned in para 3 before the 11<sup>th</sup> July 2022(11-07-2022), subject to the condition that Migration Transfer in both the outgoing and receiving Medical Colleges, is restricted to 5% of the annual sanctioned intake capacity of the college or the existing vacancy in the respective colleges.

7. The Rajiv Gandhi University of Health Sciences is requested to issue "No Objection Certificate" to eligible candidates before **16<sup>th</sup> July 2022 (16-07-2022)**.
8. The students in possession of No Objection Certificates from the outgoing Medical College, receiving Medical College & RGUHS shall apply in the prescribed format, along with an undertaking with original No Objection Certificates, to the Director of Medical Education on or before **22<sup>nd</sup> July 2022 (22-07-2022)**.
9. Wherever the Migration is sought, the Director of Medical Education shall in turn refer the cases of students to Medical Board to examine the cases on case to case basis for their geniuses on Medical grounds.
10. The Medical Board shall give its opinion regarding eligibility or otherwise for migration transfer by **27<sup>th</sup> July 2022 (27-07-2022)**.
11. The Directorate of Medical Education will issue Orders for Migration to eligible candidates on or before **02<sup>nd</sup> August 2022(02-08-2022)**.
12. Such of the students who have been given Migration Orders shall report to receiving Medical College by **06<sup>th</sup> August 2022(06-08-2022)**.
13. In respect of cases seeking migration transfer from one institution to the other located in different States and the colleges are affiliated to different Universities, such of these cases shall be referred to the Ministry of Health and Family Welfare services Government of India for further needful.
14. Wide Publicity shall be given to all the students seeking Migration Transfer, about the schedule, by putting up the circular in all the Institutional websites and Notice Boards, to ensure transparency and provide equitable opportunity to all eligible candidates.
15. All Migration transfers are to be effected as per the National Medical Commission rules and regulations. No Migration Transfer is permissible from or to the permitted or un-recognized Medical Colleges.
16. All Migration Transfers are subject to final approval by National Medical Commission or competent authorities designated by the regulators.
