4. Pay Scale:

Pay scales as prescribed by the Government of Karnataka for Government Grant in aid autonomous institutions in Karnataka.

5. Age limit:

I. <u>Teaching Posts: (As per NMC)</u>

Professor:

- a) General Merit Candidates: Maximum upper age limit for Direct Recruitment is 50 years.
- b) OBC Candidates Maximum upper age limit for Direct Recruitment is 53 years.
- c) SC and ST & Cat-I Candidates: Maximum upper age limit for Direct Recruitment is 55 years.

Associate Professor:

- a) General Merit Candidates: Maximum upper age limit for Direct Recruitment is 45 years.
- b) OBC Candidates: Maximum upper age limit for Direct Recruitment is 48 years.
- c) SC and ST & Cat-I Candidates: Maximum upper age limit for Direct Recruitment is 50 years.

Assistant Professor:

- a) General Merit Candidates: Maximum upper age limit for Direct Recruitment is 45 years.
- b) OBC Candidates: Maximum upper age limit for Direct Recruitment is 48 years.
- c) SC, ST & Cat-I Candidates: Maximum upper age limit for Direct Recruitment is 50 years.

6. METHOD OF SELECTION:

1) <u>Criteria for drawing up the merit list for Professor / Associate Professor / Assistant Professor to short listed for the interview.</u>

- a. Number of publications in National/ Indexed Journal above the stipulated number specified for the post by the NMC- 0.5 mark for each paper subject to a maximum of 2 marks.
- b. Number of publications International Journals-1 mark for each paper subject to a maximum of 2 marks.
- c. WHO fellowship in the same subject / University Gold Medal 1 mark.
- d. Higher experience than required for the post -0.5 mark for each year to maximum of 2 marks.
- e. Presentation of paper / lectures in State / National / International Conference 0.5 mark for each paper subject to maximum of 2 marks.
- f. Personality / presentation in the interview -6 marks.

7. GENERAL ELIGIBILITY CONDITIONS:

- A. Should be a Citizen of India.
- B. No man who has more than one wife living and no woman who has married a man already having another wife, shall be eligible for appointment.
- C. Candidate should be a physically & mentally fit to discharge the duties.

8. CERTIFICATE FOR CASTE RESERAVATION:

Candidates claiming reservation shall produce caste certificates i.e., SC/ST in Form No. D, Cat-I in Form No. E, Cat IIA, IIB, IIIA, IIIB Form No. F and shall be valid as per rules.

9. RURAL CANDIDATE and KANNADA MEDIUM:

- I. The Candidates who have studied and passed from 1st std to 10th std in the rural areas specified in the existing rules are eligible for claiming rural reservation.
- II. The Candidates who have studied and passed from 1st std to 10th std in Kannada Medium specified in the existing rules are eligible for claiming Kannada reservation.
- III. They shall produce valid Rural Reservation Certificate/ Kannada Medium certificate issued by BEO, necessarily countersigned by DDPI of the concerned jurisdiction, in the prescribed Form No. 2 as per Govt. Order No. දීමන්තු 96 ස්වෙත 2005, Dated: 10.08.2005.
- IV. The candidates belong to SC/ST, Cat-I, Cat IIA, IIB, IIIA, IIIB shall produce Rural Reservation Certificate in Form No.2.
- V. The Candidates belonging to General Merit shall Produce rural reservation certificate in Form No-2 along with Form -1 certificate from the concerned Tahasildar.
- VI. If the Rural Reservation Certificate produced by the candidates belonging to SC/ST, Cat-I, Cat IIA, IIB, IIA, IIIB is rejected, then they shall become ineligible for Rural Reservation.

10. PHYSICALLY HANDICAPPED & EX SERVICEMEN:

The Candidate shall produce certificate of disability from the appropriate authority as per rules. The candidates shall produce certificate of Ex-serviceman from the appropriate authority as per rules.

11. The Candidates who have passed kannada language exam as first/second language & kannada medium in the SSLC or equivalent exam shall be exempted from Kannada language test. Kannada language test will be conducted for 150 marks as per rules prescribed in this regard. If the candidate fails to pass the Kannada language test he shall not be eligible for walk-in-interview.

The time of Kannada exam is 9.00 am on 07-02-2022 (Place: KIMS Hubli) interview day. All candidates taking kannada exam shall report by 8.00 am failing which they shall not be considered for the interview.

- 12. The Candidates who are employed in the Government / Government organization shall produce "No Objection Certificate" from their appointing authorities. Candidates working in other medical colleges are also eligible to apply through proper channel only.
- 13. The Candidates claiming prior experience for the weightage should compulsorily produce the Original Salary Certificate, Experience Certificate & Copy of Form No. 16 issued by Director/Principal of the Concern Medical College/Institution.
- 14. The Candidates who are black listed by MCI/KMC and any criminal case pending /debarred candidates / dismissed from service shall not be eligible.
- 15. Reservation for Kalyana Karnataka region local persons:

 The candidates belonging to Kalyana Karnataka region shall be regarded as local persons if he/she produces eligibility certificate issued by Jurisdictional Assistant Commissioner. Revenue sub division as specified in the Govt. order No. DPAR 43 HKC 2013, dated: 29-01-2014.
- 16. The candidates who are appearing for interview shall have original documents and 2 sets of documents duly attested by gazetted officer at the time of interview.
- 17. i) The appointing authority / interview committee shall have the right to accept or reject the appointments of any candidate. Selection committee has got a full power to decrease / increase the number of posts. The appointment shall be made purely based on merit cum reservation roster as per the order of Government of Karnataka.
 - ii) The candidates selected on contractual appointment will not have any rights to claim for regular appointment.

18. MISCONDUCT:

A candidate found guilty of impersonation or submitting fabricated documents or documents which are tampered with or making statements which are incorrect or false or suppressing materialistic information or of using or attempting to use unfair means for purpose of recruitment or otherwise resorting to any other irregular or may in addition to rendering himself liable to criminal prosecution & disciplinary action, also be debarred either permanently or for a specified period or improper means in connection with his appointment shall make him / her ineligible.
